a. HEREBY AGREE TO ASSUME ALL RESPONSIBILITY AND LIABILITY FOR ALL ACTS OR ACTIVITIES, of myself, my drivers, assistants and crew and for any damage or injury that may be caused by or to any or all of us or by or to our boat, motor, properties, or possession.

b. HEREBY RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE THE AMERICAN OUTBOARD FEDERATION, INC., AS A FEDERATION, INCLUDING ALL ITS CORPORATE, ELECTED AND APPOINTED OFFICIALS, ALL MEMBERS OF COMMITTEES, REFEREES AND INSPECTORS, ITS INDIVIDUAL MEMBERS, AND ITS MEMBERS CLUBS, INCLUDING ALL OFFICERS, AGENTS, AND EMPLOYEES OF THE FOREGOING, all hereinafter referred to as "AOF Et Al" from or for any and all liability to me, my personal representatives, assigns, heir and next of kin for all loss or damage to property, which in any way grows out or results directly or indirectly from an AOF activity or part thereof, or in connection with any vessel, dock, float, barge, equipment or facility provided or used, whether or not same may be operated or controlled by "AOF Et Al" and whether arising prior to, during, or following such AOF activity; and whether any such claim may be based upon alleged active or passive negligence or otherwise, or participation in the wrong, or upon any alleged breach of statutory duty or obligation; and

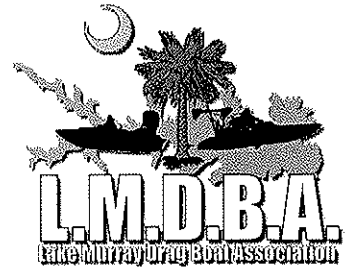
